Universal thought they would be under that, but would email a quote to him. Feeling of the board was to table it till we get the second quote from Universal. Bob reported he received a call from Jack from Scotts Construction and since they are in the neighborhood, they would patch the slide area on N. Pine Creek Rd. Tom reported he received an email from Johnson that they are not able to do Crescent Hills as they are not able to get help from Don Haefs due do to an illness. Jason will check with Bennet Brothers to see if they have the equipment and if they would be will to do it.

10. Supervisors Report.: Jason reported he visited the weed issue on Town Hall Rd and it's now a much small area and after talking to the county they advised they would suggest no longer send a letter for that small of an area. Dan reported he received a phone call from Dave Freese reference a potential water issue on the corner of Sportsman Valley Rd and County 6. Dan would like someone else to take a look it as it appears it's been that way for a while. No further reports from the board.
